Minutes: Motion was made by Dorothy Krupa and duly seconded to accept the February 4, 2018 minutes as emailed. Motion carried unanimously.

Treasurer's Report: Assistant treasurer Dorothy Krupa reported: General Checking Account: \$12,615.91, Restricted Account: \$6,326.47, Exchange Account: \$17,403.35, Wellington Fund: book \$10,000. **Motion** was made by Bob Mitchell and duly seconded to approve the treasurer's report as amended. Motion carried unanimously.

Dorothy indicated that in 2020 the FFI dues will go up to \$20 from \$15 per member. We may want to consider raising FFGM's 2020 dues to cover this. A <u>Motion</u> was made by Dorothy and duly seconded to raise the 2020 dues \$5.00 per person for members who pay after November 1^{st.} (i.e. Single membership from \$35 to \$40 and family membership from \$65 to \$75). Those who pay before November 1st will pay the current amount. Motion carried. We should include a note about the increase in the upcoming newsletter.
